sequence without EAS tag

Security manager / customer service / information desk hands a SecurityBag over to customer. The customer packs his personal items in the SecurityBag.

Security manager closes the SecurityBag.
Customer goes shopping and afterwards is going to the cash desk for payment.

sequence with EAS tag Security manager / customer service / information desk hands a SecurityBag over to customer. The customer packs his personal items in the SecurityBag.

Security manager closes the SecurityBag.
Customer goes shopping and afterwards is going to the cash desk for payment.

sequence without EAS tag

Customer passes the EAS gates (no alarm) and goes to the security manager / customer service / information desk.

The security manager opens and examines the SecurityBag and hands the personal items over to the customer.

sequence with EAS tag

Cashier opens and examines the SecurityBag and gives the personal items back to the customer.

Customer is leaving your shop. The SecurityBags are collected at the cash desk and afterwards brought back to the entry.
